The equipment leased shall remain titled to PANGEA SYSTEMS, LLC / dba VOIP2320 . PANGEA SYSTEMS, LLC / dba VOIP2320 reserves the right to remove such equipment at end of 30 days if not paid in full. If customer leases/rents the equipment and stops paying lease/rental on equipment PANGEA SYSTEMS, LLC / dba VOIP2320 reserves the right to remove such equipment.

Customer hereby grants to PANGEA SYSTEMS, LLC / dba VOIP2320, a security interest pursuant to the Colorado Uniform Commercial Code on the equipment and materials to be installed pursuant to this Agreement to secure payment of all amounts due hereunder to PANGEA SYSTEMS, LLC / dba VOIP2320 In the event of default in payment hereunder by the Customer, PANGEA SYSTEMS, LLC / dba VOIP2320, shall have all rights of a secured party under the Colorado Uniform Commercial Code, including the right to repossess the collateral, together with all other rights otherwise provided by law.

### **INTEREST AND COLLECTION EXPENSE:**

In the event of Customer's default in making any payment due hereunder, Customer agrees to pay interest on the entire outstanding balance at the rate of 1.5% per month from the date of default. In addition, if PANGEA SYSTEMS, LLC / dba VOIP2320, commences legal action to collect any sums due hereunder, the Customer shall pay all expenses associated therewith, including, without limitation, reasonable attorneys' fees, deposition expense, and expert witness fees
